I hereby agree to breed my mare _____ Reg. # _____ to stallion **Metalic AI** for the _____ season.

I hereby further agree:

A breeding fee of \$ _____, is payable to Metalic AI, LLC with this contract. This contract, completed and intact, must be returned to: Metalic AI, LLC, for approval signature. This contract becomes valid upon the signature of stallion owner or its authorized representative. This contract is non-transferable without the approval of stallion owner.

1. Chute fees: \$650 non-refundable chute fee payable to Santa Lucia Farm, Inc.
2. Diligent efforts will be made to settle my mare, however, if for any reason she does not settle, I will not hold the stallion owner or his representatives liable. The breeding season will begin February 10th and close July 1st, _____.
3. A PHOTO STATIC COPY OF THE FRONT AND BACK OF THE MARE’S REGISTRATION CERTIFICATE MUST BE FURNISHED.
4. Live Foal Guarantee: Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if the foal is still born, a return breeding will be guaranteed the following year, providing proper notification is given and all fees are paid in full in accordance with the terms of this contract. Proper notification is a written certificate by a licensed veterinarian within seven (7) days stating that the mare has slipped or produced a non-viable foal. Mare owner verifies that such abortion or death did not result from any act or omission of the Owner. Rhino vaccinations must be administered as indicated by the individual drug manufacturer as the mare progresses though her pregnancy. Failure to do so will void the Live Foal Guarantee.
5. H.E.R.D.A. Guarantee - This guarantee provides that should the result of this contracted breeding develop H.E.R.D.A., proper requested documentation must support this finding. Metalic AI, LLC will allow a rebreed for another mare, the original bred mare/dam of the H.E.R.D.A. foal will not be accepted for this rebreed.
6. Should the above named stallion die or become unfit for service Metalic AI, LLC. reserves the right to fulfill this contract using available frozen semen. Chute Fee is non-refundable.
7. This contract provides for one (1) live foal and one (1) breeder’s certificate.
 - 7a. Embryo Transfer. I understand that if an embryo transfer is performed and multiple embryos are recovered during embryo harvesting, I will be held accountable for an additional breeding fee \$ _____, within (30) days of confirming pregnancy.
 - 7b. A “Breeder’s Certificate” will be issued upon notification of the birth of the foal, providing all fees are paid in full.
8. Waiver of Liability: I understand and agree that neither Metalic AI, LLC., it’s representatives, nor Santa Lucia Farm, Inc., will be responsible for accidents, sickness, or death to my mare and/or foal. Furthermore, I agree that the above named parties shall not be held liable for any negligence or errors and that the above named parties may exercise their judgment in supervising and caring for my mare and/ or foal. I agree that the above named parties assume no liability whatsoever for my mare and/or foal or mare owner.
9. Complimentary and/or donated breeding’s are only good for the year issued.
